



### **Whangamata SLSC Hireage Terms and Conditions.**

This is a **smoke free club** and smoking or vaping is **not permitted** anywhere within the club or on the club grounds

Whangamata Surf Life Saving Club is a charitable organisation dedicated to keeping people safe in the aquatic environment. Please respect our Club house and facilities so others can benefit from them.

We are an emergency service. All other areas are strictly out of bounds. In an emergency police, fire brigade, ambulance and club personnel have right of entry at all times.

#### **Bond**

A bond of \$500 is payable for all clients, irrespective of whether or not they are members, in order to secure a booking. This bond will be refunded providing the facilities are left 'as found' and all conditions have been complied with to the satisfaction of the Club Host (Club Manager or Club Administrator).

**Please note bookings are not confirmed until the bond has been paid and confirmation is sent in writing from the Club Administrator.**

#### **Cancellation**

The club reserves the right to cancel any booking without notice.

#### **Cleaning**

The Club contracts a cleaner to clean to a commercial standard using commercial strength cleaning products. A fee for cleaning based on hireage will be included in the total cost to hire. No exceptions.

#### **Hire of Accommodation**

Includes accommodation block, toilets and showers and additional ablution block.

#### **Hire of Hall**

Includes lounge, balconies, bar, (where applicable), toilets and kitchen area.

#### **Hire of Annex**

A stand-alone room with no access to other areas of the club.



### Keys

1. Except for schools, payment must be upfront before keys are issued.
2. The Hirer is responsible for the safe return of the keys.
3. Loss of keys may result in all locks being changed. The full cost will be invoiced to the Hirer.

### Conditions of hire - Hall

1. Music must be turned off by 12 midnight.
2. Smoke machines are not permitted because of the fire risk. Alarms operate.
3. Hall is to be locked, alarmed and vacated by 1am
4. The disposal of **all** rubbish and bottles is the Hirer's responsibility unless prior arrangements have been made.
5. Surplus food is to be removed from fridges and freezers (including left over ice).
6. All areas are to be left 'as found' i.e. clean and tidy, including the ovens and barbeques

### Conditions of hire - Accommodation

1. Bedding, towels and pillows are the responsibility of the Hirer
2. Mattresses must not be removed from bunks
3. No food or drink other than water is to be taken into *or* consumed in the accommodation block

### Conditions of hire – Annex

1. The disposal of **all** rubbish is the Hirer's responsibility unless prior arrangements have been made.
2. Surplus food is to be removed from fridge
3. Areas are to be left 'as found' i.e. clean and tidy
